











Where Should We Invest Our Resources?

- Advanced Driver Assistance Systems (ADAS)
 - Dramatically reduces risk of catastrophic accidents
 - Provides actionable data!
- Camera Systems
 - Exoneration
 - More data!
 - Risk scoring
 - Coaching related to driver behavior (targeted interventions)
- Learning Management Systems (LMS)
 - Assign targeted training that addresses root causes
 - Knowledge gap data!



Where to Invest

- CDL Monitoring Services
 - Automatic MVR updates (most states)
 - No more waiting 12 months to discover a change in CDL status
 - Risk scoring
 - Actionable data!


- Fleet/Safety Management Systems/ Maintenance Management Systems
 - Captures data from various sources and presents it in an actionable way
 - Improved efficiency
 - Risk scoring
 - Captures more data!

Integrate your LMS and Camera Systems!

- Set allowance thresholds
- Automatically assigned training

61% Reduction in speeding events in 6 months!

Assessing Risk

- Data analytics identifies your risk exposures
 - Focus on high-risk drivers, routes, operational practices, maintenance issues
 - Pareto Principal (80/20 Rule)
- Identify your root causes!
 - The 5 Why Method
 - An instinctive way to determine how the world around us works
 - We were all experts in this approach as children



The Role of a Modern Safety Professional

Today we are Companywide Proactive Problem Solvers!

- Root causes will lead into other functions of the business
- Knock down imaginary barriers that limit capability and effectiveness
- Empower your safety department to eliminate risk in all areas of the business!
- Continuous improvement culture



Does your safety team have a seat at the table?

This Sounds Great...But Does it Work?

Case Study- Skelton Truck Lines

- 71% Reduction of risky driving events
- 69% Reduction of speeding events
- 87% Reduction of following distance events
- 50% reduction in claim frequency
- 92% Reduction of the average cost per claim

In just 5 months...



Ok... But, What About Long Term Results?

Case Study- Boyle Transportation

- Over 8 years of utilizing this approach to safety
- 11 total preventable claims in the last 3 years (2021-2023)
- Zero preventable recordables since 2019
- Average cost per claim- \$5,507
- Continuous improvement does not stop!
 - 32% reduction in speeding events over the last 12 months
